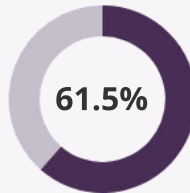

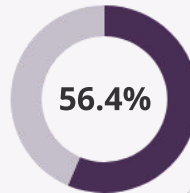

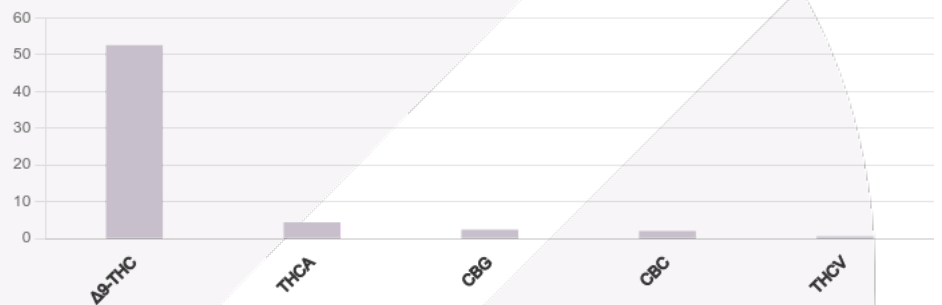
**TOTAL CANNABINOIDS**



**TOTAL THC**

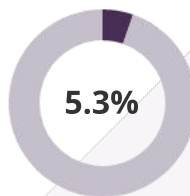
