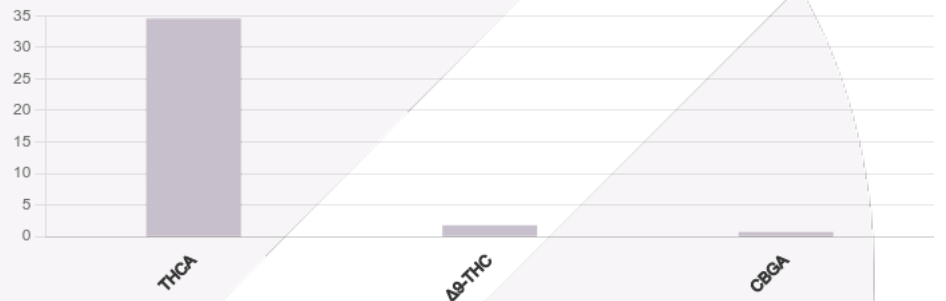
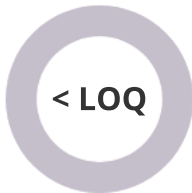
TOTAL CANNABINOIDS

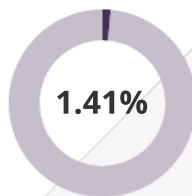
