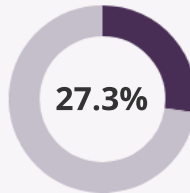

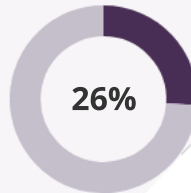

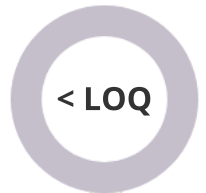

TOTAL THC

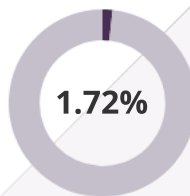
