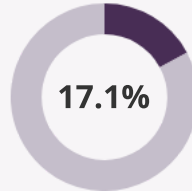

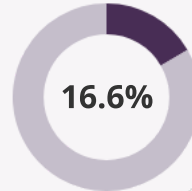

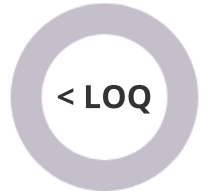
TOTAL CANNABINOIDS

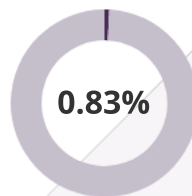
