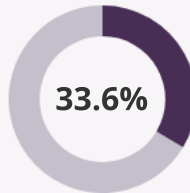

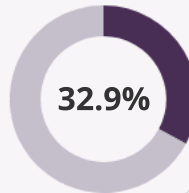

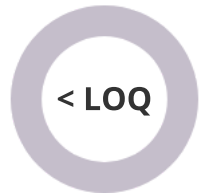

TOTAL THC

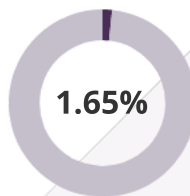

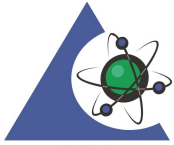
