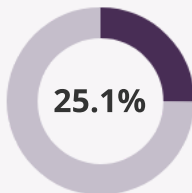

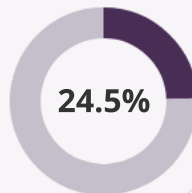

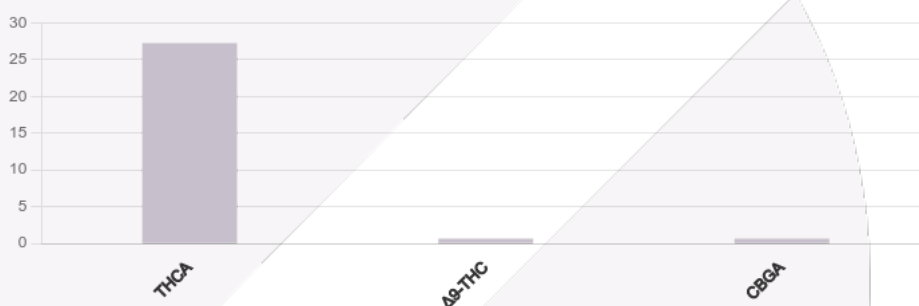
TOTAL CANNABINOIDS



TOTAL THC

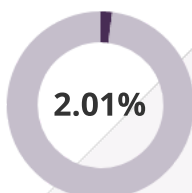

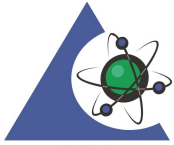
