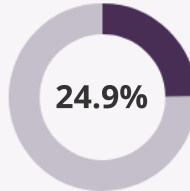

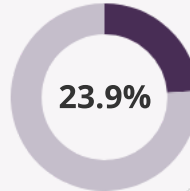

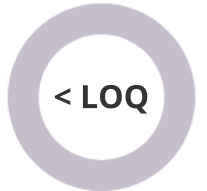
TOTAL CANNABINOIDS

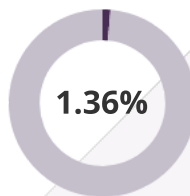
