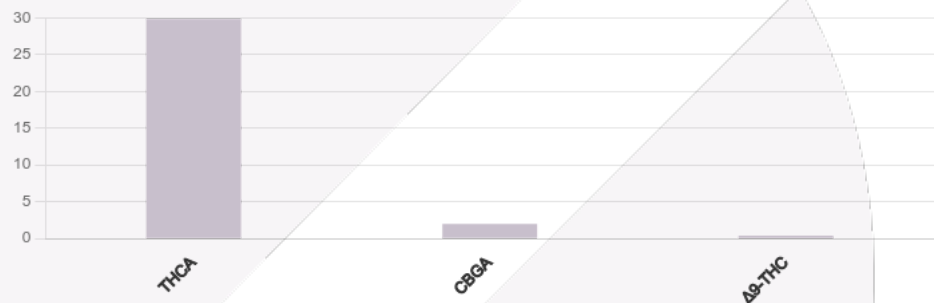
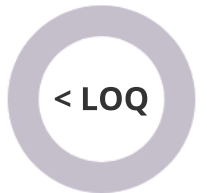
TOTAL CANNABINOIDS

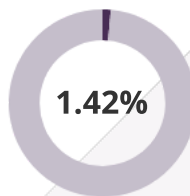
