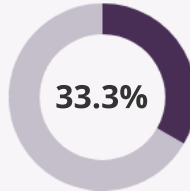

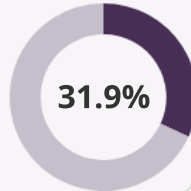

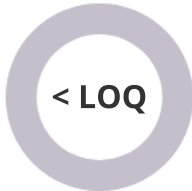
TOTAL CANNABINOIDS

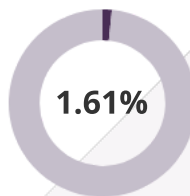
