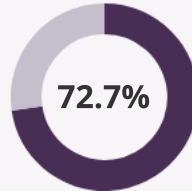

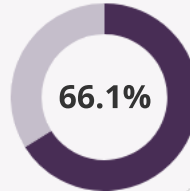

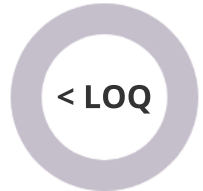

TOTAL THC

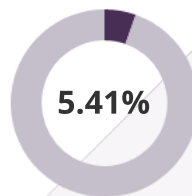
