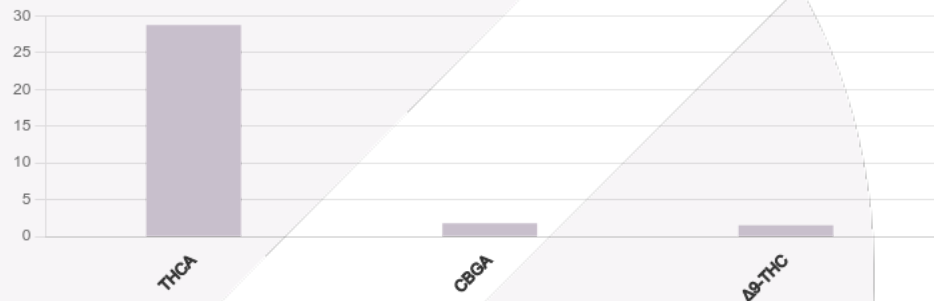
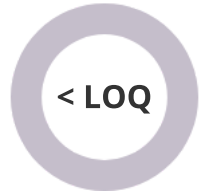
TOTAL CANNABINOIDS

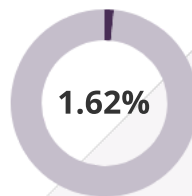
