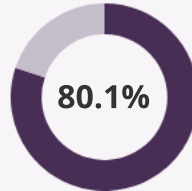

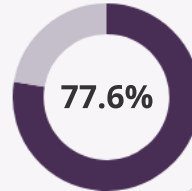

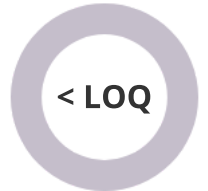
TOTAL CANNABINOIDS

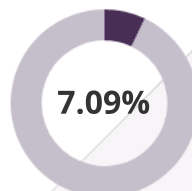

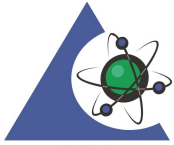
