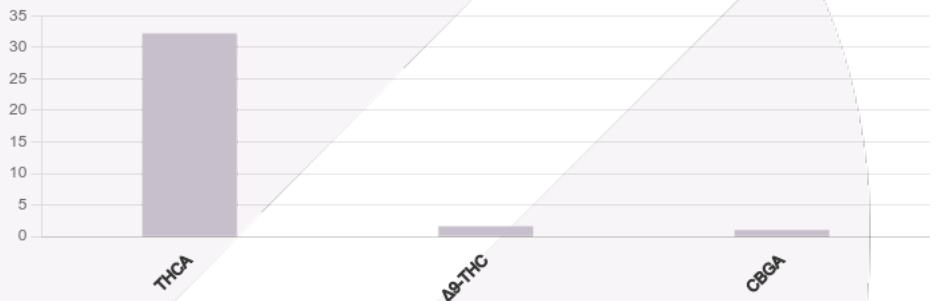

TOTAL THC

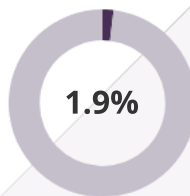
