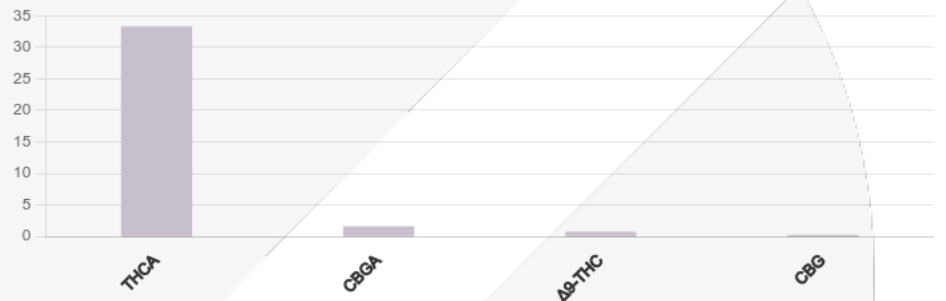
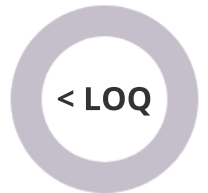
TOTAL CANNABINOIDS

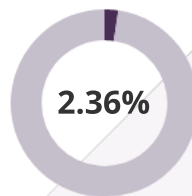

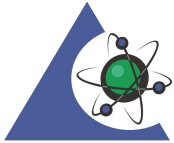
