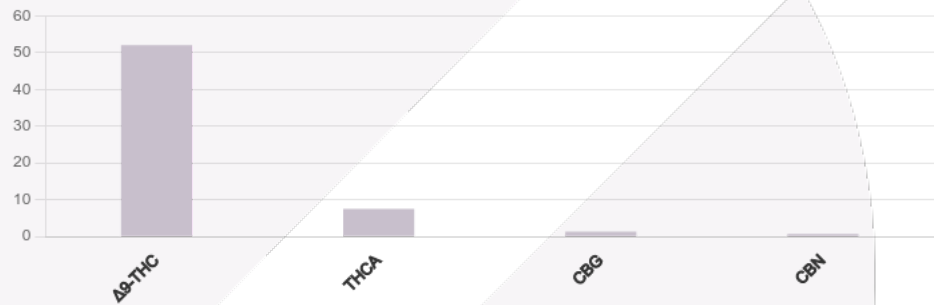
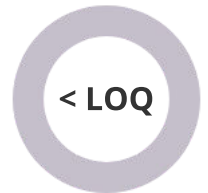
TOTAL CANNABINOIDS

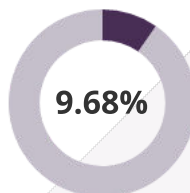
